GENERAL CONTEST RULES APPLY AND SPECIFIC CONTEST RULES FOR THIS CONTEST.

1. ELIGIBILITY.

Geographical and Age Consent Requirements:

Unless otherwise specified, each Contest is open to only to individuals who (i) are legal U.S. residents, (ii) who are 18 years of age or older at the time of entry and (iii) who reside in INDIAN RIVER, ST LUCIE, BREVARD, MARTIN, OR OKEECHOBEE COUNTY. (proof of age and residency required before awarding the prize).

The Entrant must be the designated caller, from all callers calling-in to the participating stations, to the phone number announced; the designated caller, if eligible, will be declared a finalist for contest..
